In the reference 1st cited, the Government of Andhra Pradesh have kind enough in issuing G.O.Ms. No. 242 PR & RD (Estt. IV) Dept., in Re-designating the nomenclature of the post of Superintendents as Administrative Officers in the departments of Panchayat Raj & Rural Development which was previously equal to that of Superintendent in MPP & ZPP and also in Revenue Department by conferring gazetted status, subject to the condition that the extent of reservation to locals in direct recruitment remain unchanged even after it is Gazetted.

In the reference 2nd cited, the Principal Secretary to Government, Tribal Welfare Department, Govt. of A.P. while enclosing the representation of APTREINTA requested the Secretary to send the remarks in the matter to Government immediately.

It is to submit that, there are mainly 8 ITDAs and 5 Non-ITDA Districts under control of APTWREI Society, Gurukulam Head Office. Altogether, there are Thirty Three Superintendents (33 nos) posts have

been sanctioned for 184 Gurukulam institutions including 4 deputation posts at Head Office, Gurukulam, Amaravati. Out of them, Six (6) Superintendents are working in Gurukulam Head Office, Amaravati., Eight (8) Superintendents have been discharging their legitimate duties in ITDAs in the capacity of Gurukulam cell incharges and remaining have been rendering their services in the capacity of Superintendents at various school and college levels of Tribal Welfare Gurukulam institutions since a long back without any promotional avenues.

Further, it is to submit that, it is essential to re-designate the nomenclature of the superintendents working in ITDAs & NON-ITDA Districts in the capacity of Gurukulam cell in-charges as Administrative Officers conferring Gazetted Status to the post of superintendents where I.A.S. Officers are being played a key role in district administration.

There is no any financial loss also to the Government, if the nomenclature of the superintendents will re-designate as Administrative officer conferring Gazetted Status as laid in G.O.Ms. No. 242 PR & RD (Estt.IV) Dept., dated: 24-12-2018 adopting the procedure as that of being implemented in Panchayat Raj & Rural Development (Estt. IV) Department.

Submitted for kind approval of the proposals and issue orders re designating the nomenclature of the superintendents working in ITDAs & Non-ITDAs and other gurukulam institutions conferring the Gazetted Status.
